Show enclosures for outdoor pools per municipal code section 7-553 & 7-554, which require a 4' fence with a locking gate. The fence around the pool shall be kept closed and locked.

**NOTICE:** This permit becomes null and void if work or construction authorized is not commenced within six (6) months or if construction or work is suspended or abandoned for a period of six (6) months at any time after work is commenced.
