



Below is a list of fees/costs and rates associated with water/sewer/sanitation services provided by the City of Shawnee/Shawnee Municipal Authority. ### **Fees/Costs**

**Meter Maintenance Fees:** A monthly meter maintenance fee will be assessed to each water service account. For commercial accounts, the fee is based on the size of the meter servicing the service address.

Residential Accounts: \$6.00 per month per meter

### **Other Fees:**

Processing Fee: A processing fee of \$25 will be assessed to each new residential water service account at the time the account is established.

Residential Deposit: The residential water service deposit will be \$75 and will be due at the time the account is established.

Residential Solid Waste (Garbage) Only Deposit: The residential solid waste (garbage) only deposit will be \$20 and will be due at the time the account is established.

Commercial Deposit (Water/Sewer Only): The commercial water service deposit for a business or commercial establishment shall be based on the size of the meter and demand for service. The deposit shall be such sum as will at least cover three times the monthly bill of the consumer according to established rates and shall be determined by the City Clerk or designee.

Transfer of Service Fee: A transfer of service fee of \$25 will be assessed to a customer's account when that customer transfers water service from one address to another within the city limits of Shawnee.

Rescheduling Fee: A rescheduling fee of \$25 will be assessed to a customer's account when an adult is not present at the service address for the scheduled time for the water service to be turned on and a time must be rescheduled.

Late Payment Penalty: All water bills are due and payable upon receipt. If the bill is not paid by the due date, water service shall be subject to being discontinued. If the bill is not paid in full on or before the due date, a late payment penalty of 10% of the bill, or a minimum of \$1.25, shall be assessed.

Cutoff Notice Fee: A cutoff notice fee of \$5 will be assessed to a customer's account when the account is not paid in full and a cutoff notice is sent to the account holder.

After-Hours Connection Service Fee: If a customer desires to have water services turned on after the normal business hours of the Customer Service office, a reconnection fee of \$50 shall be paid in advance of the reconnection (payment must be made 30 minutes prior to close of business for the Customer Service office and a two-hour window of time for reconnection will be given to the customer).
