## PRELIMINARY FINDING OF NO SIGNIFICANT IMPACT

## TO: ALL INTERESTED AGENCIES AND PUBLIC GROUPS

As required by the Oklahoma Department of Environmental Quality (DEQ) Regulations governing the use of the State of Oklahoma Drinking Water State Revolving Fund (DWSRF), as authorized on January 28, 1997, an environmental review has been performed on the proposed action below:

Shawnee Municipal Authority
Pottawatomie County, Oklahoma
DWSRF Project Number: P40-1020504-03
Estimated Project Cost: \$19,910,000.00

The proposed project is Water Treatment Plant (WTP) improvements. All proposed improvements will be made within the boundary of the existing WTP property.

Current environmental conditions in the area show that air quality meets DEQ ambient standards. The existing use of the land will not be permanently changed as a result of the proposed project. There are some short term environmental impacts associated with this project, such as storm water runoff issues, solid waste generated by equipment, materials packaging being windblown, mud and debris tracked off-site by the contractor, dust, and noise. These short term impacts are negligible and can be mitigated through good construction practices.

There are no national or state parks, or wildlife conservation areas near the proposed project areas. Tourism is expected to be unaffected by this project. Pottawatomie County does not have any scenic rivers.

This project is not likely to adversely affect endangered or threatened species. Prime farmland, forestland, rangeland, and wetlands will not be affected. No disproportionate impact to low income or minority communities is anticipated.

There are no known historic sites in the planning area. However, if historical artifacts are found during construction, construction will be stopped and the State Historical Preservation Officer will be contacted. Comments from reviewing federal and state agencies and other interested groups indicate that no long-term adverse impacts to environmental resources should result from this project.
